## THE RURAL MUNICIPALITY OF ROSSER BY-LAW NO. 6-23

## BEING A BY-LAW TO OPEN A MUNICIPAL ROAD AND TO RENAME CERTAIN ROADS WITHIN THE MUNICIPALITY

WHEREAS section 289 of the Municipal Act S.M. 1996, c. 58 of Manitoba states:

A municipality may open land for public use as a municipal road by (a) passing a by-law opening the road; and (b) registering the by-law and a plan at the appropriate land titles office.

**AND WHEREAS** section 232(1)(d) of the *Municipal Act* S.M. 1996, c. 58 of Manitoba states:

- 232(1) A council may pass by-laws for municipal purposes respecting the following matters:
  - (d) municipal roads, including naming the roads posting the names on public or private property, and numbering lots and buildings along the roads;

**AND WHEREAS**, the Council of the Rural Municipality of Rosser deems it necessary and desirable to open a municipal road over, upon, and across part of the lands described as Lot 18, Plan 69235 WLTO and to rename certain other roads located in the NE1/4 21-11-2E;

**NOW THEREFORE**, the Council of the Rural Municipality of Rosser in open Council assembled, enacts as follows;

1) That a municipal road be and is hereby opened and established over, upon and across the lands described as follows:

ALL THAT PORTION OF LOT 18, PLAN 69235 WLTO DESCRIBED AND SHOWN AS RED FIFE ROAD ON THE PLAN OF RED FIFE ROAD TO BE OPENED IN THE NE1/4 21-11-2E PREPARED BY JESSE PAUL SIMON CARELS, OF THE RURAL MUNICIPALITY OF ST. CLEMENTS, MANITOBA LAND SURVEYOR, ON FILE IN THE WINNIPEG LAND TITLES OFFICE AS DEPOSIT NO. 1140/2023 AND SWORN TO BY HIM ON THE 28TH DAY OF SEPTEMBER, 2023.

and that the road is hereby named Red Fife Road and the said lands are hereby dedicated to the public for that purpose.

2) That the section of municipal road currently known as Durum Drive be renamed West Creek Way and which is described and identified as its new name WEST CREEK WAY on the Plan of Public Road in the NE1/4 21-11-2E prepared by Jesse Paul Simon Carels, of the Rural Municipality of St. Clements, Manitoba Land Surveyor, on file in the Winnipeg Land Titles Office as Deposit No. 1279/2023 and sworn to by him on the 2nd day of October 2023 be and is hereby renamed to West Creek Way.

- 3) That the section of municipal road currently known as Durum Drive be renamed Red Fife Road and which is described and identified as its new name on the Plan of Public Road in the NE1/4 21-11-2E prepared by Jesse Paul Simon Carels, of the Rural Municipality of St. Clements, Manitoba Land Surveyor, on file in the Winnipeg Land Titles Office as Deposit No. 1279/2023 and sworn to by him on the 2nd day of October, 2023 be and is hereby renamed to Red Fife Road.
- 4) That the road opening and road name changes shall take effect upon the by-law being registered at The Property Registry (Winnipeg Land Titles Office).
- 5) That the said Plan of Red Fife Road to be Opened (Deposit No. 1140/2023 WLTO) and the said Plan of Public Road (Deposit No. 1279/2023 WLTO) are hereby adopted and approved, and the Chief Administrative Officer is authorized and directed to endorse the said plans for identification, placing thereon their signature, under the corporate seal of the municipality, together with a reference to this bylaw.
