

ROSSER TRANSFER STATION **SUMMER 2018 Update & Changes**

* **Please note we are not a Household Hazardous Waste Site.**

The transfer station would appreciate if all loose light garbage or recyclables be placed in the appropriate bags before they are put in the waste bin.
This is to avoid garbage being blown around by the wind.

The Rosser Transfer Station is only for the use of Rosser Residents, Ratepayers

Residents and Ratepayers – may use all designated areas for:

- recycling
- household waste
- composting
- brush
- small amounts of clean lumber
- tires
- scrap metal
- used oil
- electronic recycling
- fridges
- freezers
- water coolers
- air conditioners
- dehumidifiers

Limit 2 ½ ton loads per day.

Household Waste (first 2 bins as you go up the gravel hill)

These bins are **NOT** for Hazardous Waste, Tires, Drums or Containers, Liquid or Chemicals, Appliances, Batteries

We DO NOT accept Railway ties or demolished buildings, derelict vehicles or equipment.

Recycle Bin – (third or last bin as you go up the gravel hill)

Accepted Items (blue bags or clear bags only-or just use the chute).

- Glass jars (food jars only)
- liquor and wine bottles
- food aluminum cans
- tin food cans
- newsprint and paper
- insert flyers and junk mail
- magazines
- phone books
- household paper
- shredded paper and envelopes (be sure to shred all private documents such as bank statements, etc).

- Only plastics with **recycle triangle** on it with the number **1, 2, 4, 5, 6, 7** printed in the triangle only.



***All containers must be empty & all other plastic is household waste including all plastic bags.**

corrugated cardboard and boxboard. (Please flatten boxes)
cardboard egg cartons and paper tubes, milk and juice cartons, juice boxes, pizza boxes, cereal boxes, etc.

For Used Oil, and Antifreeze

See signs as you proceed into main area - Non Commercial Only.

- Blue oil storage container for used oil.
- White storage container for used antifreeze
- Drums for used oil filters
- Bag for empty antifreeze and oil containers. (Please remove lids on pails before leaving them).

Light Bulbs: CFL or spiral lights, florescent light bulbs & mercury vapour bulbs – Leave all with land fill attendant - **Do not** put in household or recycle bins
Regular incandescent light bulbs or LED lightbulbs go in household waste bins. (Not in recycle bin)

Scrap Metal Bin: container on site for aluminum, copper, steel and large appliances (Stoves, dishwashers, washers and dryers, etc).

Batteries: Go in green container on hill, marked with sign.

Propane Tanks: Go in designated area marked with sign.

Tires: Go in designated tire area.

Paint and Aerosol containers (unused or empty): Put in plastic container at middle door of green container.

Cell phones – Go into a box in front of green container (door marked with batteries).

Printer Ink cartridges/laser cartridges - Go into a box in front of green container (door marked with batteries).

Electronics Recycling- SEE ATTACHED SHEET

Compost Material- designated area.

Brush or clean unpainted wood - designated area.

Painted or treated wood, mattresses and furniture: Go into the 1/2 size blue bin on south side.

Cooking Oil: Cooking oil goes in middle door or sea can on hill.

What we do not Recycle - Do not put in recycle bin or household waste bin

- No household hazardous waste containers containing any liquids, pesticides, herbicides, fuel or chemicals
- non-empty adhesive containers
- fire extinguishers
- spray foam containers
- paint thinner

Other items not for recycle bin - Put in Household waste bins

- aluminum foil, foil pie plates, foil or gift-wrapping paper
- food containers made of foil or foam or frozen wrappers
- plastic bags, grocery bags, regular garbage bags, cellophane
- foam packaging, foam egg cartons or foam meat trays, wax or foil coated paper
- dishes, crystal or ceramics
- food waste
- napkins, paper towels or tissues, bio-based or compostable bags
- plastic furniture, textiles or toys
- VHS, cassette tapes or CDs (these can go in the electronics recycling area)
- clothing
- Window glass, mirrors or any other broken glass
- Steel pots and pans or scrap metal
- Empty caulking tubes

Paint Products Accepted (Empty or unused) * Marked Green Bin on Hill:

Max. container size is 25 litres and 680 grams or 24 oz. for paint aerosols.

- interior and exterior water-based latex, acrylic and oil-based alkyd, enamel architectural paint
- deck, porch and floor coating (including elastomeric)
- varnish and urethane (single component)
- concrete and masonry paint, drywall paint, stucco paint, textured Paint
- undercoats and primers (metal, wood, etc.)
- marine paint*
- wood preservatives*
- wood finishing oil
- melamine, metal and anti-rust paint , stain, and shellac
- swimming pool paint (single-component)

- stain blocking paint, block fillers and sealers
- wood, masonry, driveway sealers and water repellants (non-tar based or bitumen based)
- paint aerosols of all types including automotive, craft and industrial products

*Unless registered under Pest Control Products Act. (with P.C.P. Registration number on the label)

Paint Products Not Accepted (Empty or unused)

*** Take to household hazardous waste site**

Industrial paints and finishes

Paints or wood preservatives that are registered as a pesticide under the Pest Control Products Act (has a P.C.P. Registration number on the label)

- non-aerosol craft paint, non-aerosol automotive paint
- two part or component paints containing a catalyst or activator
- roofing products (patch, tar or repair), tar or tar/bitumen-based products
- traffic or line marking paint
- resins, fibre-glass
- paint thinner, mineral spirits or solvents, deck cleaners
- colourants and tints
- caulking compound, epoxies, glues or adhesives
- other household chemicals, lubricants
- nitro-cellulose based paints

Other Non-Accepted Items (Empty or unused)

*** Take to household hazardous waste site**

- acetone, BBQ lighter fluid, camping fuel, fondue fuel
- flammable degreasers, lubricants and liquid adhesives and solvents
- flammable fuel treatment and additives
- methanol or methyl hydrate
- paint stripper, paint thinners (Varsol), paint and varnish remover, turpentine
- gasoline, diesel, kerosene, automotive additives
- rust remover, masonry cleaner
- pool and hot tub cleaners, bleach and drain cleaners (unused containers)
- grout cleaner
- furniture stripper, caulking compound
- tar and bug remover, insect repellants, disinfectants and pet products
- mineral spirits
- commercial, industrial or agricultural products, fertilizer
- mercury switches
- wine and distilled spirits
- ammunition (check with local law enforcement agency)
- drugs and medicines (check with local health officials)

- medical sharps (check with local health officials)
- cosmetics
- any product with WHIS or GHS label (symbol contained in red diamond)

*If unsure where to put something, please see landfill attendant. We do not take unidentifiable, unknown or unlabeled products. Products must be in their original container with label intact.

Unused non-empty household hazardous waste materials and liquids must be taken to a Household Hazardous Waste depot as we are not able to accept them.
